

Grant of Unlisted Employee Share Options

Buru Energy Limited advises that the Company's Board of Directors have approved the grant of unlisted options to employees of the Company under the terms of the Company's Employee Share Option Plan ("ESOP").

The Board considers that participation in a long term incentive scheme structured around equity based compensation is necessary and appropriate to attract and retain the highest calibre of professionals to the Company. The ESOP aligns the interests of employees with shareholders and rewards employees for delivering value to shareholders through share price appreciation. No options are granted to the Executive Chairman or any other Director under the terms of the ESOP.

The ESOP was last re-approved by shareholders for a further three years at the Company's 2018 AGM. The Notice of Meeting for that AGM included a summary of the terms of the ESOP. The Appendix 3B notice relating to the issue of the unlisted options is attached.

A total of 5,950,000 unlisted options have been granted to 38 employees. The options have an exercise price of \$0.40, an expiry date of 31 December 2021 and vested immediately on the grant date. If all of these options were exercised into shares they would reflect ~1% of the Company's current issued capital.
