ASX ANNOUNCEMENT (ASX: BRU) 3 October 2011

Share Purchase Plan Closed

Buru Energy Limited (“**Buru**” or “**Company**”) advises that the Share Purchase Plan (“**SPP**”) announced by Buru on 12 September 2011 closed on 26 September 2011 as scheduled.

282 applications were received for a total of 3,722,928 Buru shares raising a total of \$2,420,000. An Appendix 3B is attached.

The allotment date for these SPP shares is 4 October 2011. All applicants will receive their full allotment under the SPP. All shares issued under the SPP rank equally with existing Buru shares.

The SPP was offered to provide the opportunity for existing Buru shareholders to gain further exposure to Buru by acquiring up to \$15,000 worth of new Buru shares at \$0.65 per share. This was the same price as the Institutional Placement announced on 2 September 2011. No brokerage or transaction costs were payable under the SPP. The SPP was not underwritten.
